By special resolution  
Delete Article 5 in its entirety and replace with:

## **APPLICATIONS FOR MEMBERSHIP**

5.1 Each District Council must nominate one individual (who must be a member of the District Committee) (its "representative") to apply for membership of the Company on its behalf. Each representative must apply on the form prescribed by the Board together with a copy of the decision of the District Council nominating the representative. The Board shall accept such nomination and election to membership shall be ratified at the next meeting of the Board. The representative and the National Secretary (Legal & Corporate) shall be informed of the decision within 14 days.

5.2 A District Council may at any time by decision of its District Committee revoke the authority of its representative and, if it so wishes, nominate another representative to apply for membership of the Company on its behalf. A replacement representative must apply for membership in accordance with Article 5.1.

5.3 Every nomination or revocation of authority made by a District Council under this Article 5 shall be made by a simple majority of those voting at the District Council or District Committee meeting at which such vote is taken; and:

(a) written notice in hard copy form signed by its District Secretary shall be sent to the Company's registered office or to any other address specified by the Company for this purpose; or

(b) written notice in electronic form authenticated in accordance with the provisions of section 1146 of the Companies Act 2006 by its District Secretary shall be sent by electronic means to an address that the Company has specified for this purpose.

5.4 A representative whose authority has been revoked shall cease to be a member of the Company on the date that the District Committee makes that decision. The District Secretary in accordance with Article 5.3 shall notify the National Secretary (Legal & Corporate) of such decision within 14 days of such decision being made.

5.5 All admissions of persons as members of the Company and all cessations of membership (for whatever reason) shall be recorded in the Register of Members of the Company in accordance with the requirements of the Companies Act 2006.

5.6 The representative of a District Council who is admitted to membership of the Company shall be one of that District Council's delegates at a National Council meeting who are appointed in accordance with Article 27.4(d). Such representative may appoint a proxy in accordance with the provisions of Article 21.

In Article 8.3(c), delete the words "Article 5.3 or 5.4" and replace with "Article 5.2".

In Article 14.2, delete the word "members" and replace with the word "delegates".

In Article 27.4(d), delete the word "representatives" and replace with the word "representative". Also, add a new sub-paragraph 27.4(e) (and re-letter subsequent sub-paragraphs) as follows:

(e) elect the delegates (who must be members of the District Committee) to represent the District Council at a National Council meeting. The number of delegates (one of whom shall be

that District Council's representative appointed in accordance with Article 5) who may represent a District Council at a National Council meeting shall be determined as follows:

- (i) a District Council having up to and including thirty affiliated clubs on 30 September in each calendar year shall be represented by a maximum of two delegates;
  - (ii) a District Council having between thirty-one and forty-five (inclusive) affiliated clubs on 30 September in each calendar year shall be represented by a maximum of three delegates; and
  - (iii) a District Council having more than forty-five affiliated clubs on 30 September in each calendar year shall be represented by a maximum of four delegates;
- and in the event of any District having a delegate appointed as Chairman such District shall be entitled to nominate a replacement delegate, in which case the Chairman will lose the right to vote, except that the Chairman has the right of a casting vote.  
Any delegate unable to attend a National Council meeting shall inform his District Chairman who may appoint another member of that District Committee in his place.

In Article 32.2(b), first line, delete the comma after the word "members", delete the word "members" and replace with the word "delegates" and delete the comma after the word "retires".

In Article 32.3(e), first line, delete the comma after the word "members", delete the word "members" and replace with the word "delegates" and delete the comma after the word "rotation".

In Article 32.4(b), second line, delete the words "a member qualified to vote at the meeting" and replace with the words "the relevant District Secretary or District Chairman".

In the last paragraph of Article 32.4, delete the words "he is a member of the Company" and replace with the words "such person is" and delete the words "Article 5.8" and replace with "Article 27.4(e).

*Explanation: At the 2015 National Council AGM, new Articles of Association were adopted by a unanimous vote. One of the major changes made to the Articles at that time was the requirement that each District had to nominate individuals to be members of the Company so as to satisfy the requirements of the Companies Act 2006. This is proving difficult to administer in practice. The purpose of the proposed amendment is to simplify that procedure whereby each District would need only to nominate one individual to be a member of the Company. The procedure whereby a District Council nominates its delegates for the National Council meeting, and the number of delegates each District is entitled to have represent such District at a National Council meeting, remains unchanged.*

*Please note – if this amendment to the Articles is approved, each District would need to revoke its authority of its current representatives to be members of the Company so as to reduce the number of members to one per District.*

*Explanation: Email now is often the preferred means of receiving communications. This amendment provides for that alternative.*

Article 31.1 (page 76)

Delete Article 31.1 in its entirety and replace with:

"An eligible club that wishes to become an affiliated club must:

(a) apply on the prescribed form and pay the annual subscription to the District Secretary of the District Council in which the eligible club's headquarters are located or in which it normally intends to promote events; or

(b) apply via the Cycling Time Trials' website."

*Explanation: Affiliation can now be applied for online. This is a tidying up exercise.*

*Explanation: Currently the Articles of Association of CTT only state that information can be dispersed to Districts or clubs if a decision is made to do so. We believe that much greater transparency is required in the actions of the Board so that member clubs can have confidence that the sport is being progressed and that new ideas and innovations are considered and acted upon.*

These events are carried out on measured, legal courses with CTT approved timekeepers which means that the information is easily accessible to all event secretaries, allowing those who have handicapped or over-subscribed events to quickly and reliably check information provided by riders.</i></p>		
17.	<p>By Liverpool DC</p> <p><b>Entry to Events</b> Regulation 11(a)(ii) (page 340) After the word "machine" insert the words "in a Type A event" so it reads: ii) performances relative to that machine in a Type A event. N.B. Where a performance has been declared null and void it must not be included on any entry form. <i>Explanation: In 2017 there have been significant improvements in the CTT website ensuring that riders times are accurately and reliably updated. These events are carried out on measured courses approved for Type A events with CTT approved timekeepers which means that the information is easily accessible to all event secretaries, allowing those who have handicapped or over-subscribed events to quickly and reliably check information provided by riders.</i></p>		
18.	<p>By West DC</p> <p><b>Competitor's Machine</b> Regulation 14 (page 341) Delete Regulation 14(d) in its entirety <i>Explanation: In a press release on 13/4/17, the Board communicated that considered Regulation 14(d)(ii) "no longer fit for purpose" and that it thereby introduced "for the 2017 season a moratorium on applying any sanction against riders who are currently contravening this technical regulation". Given that the regulation will not be enforced it should be deleted so as to avoid confusing anyone who reads the rules but is not aware of the press release.</i> <i>In the same vein there are numerous breaches of Regulations 14(d)(i) and 14(d)(iii) which would appear to have little consequence in practice and against which no enforcement action is taken. It therefore makes sense to tidy things up by removing these regulations as well.</i></p>

22.	<p>By the Board of Directors  <b>Signing-on Sheet and Signing-out Sheet</b>  Regulation 17(b) (page 343)  Insert a new sentence at the end of sub-paragraph (b) as follows:  "A rider who fails to so sign the official Signing-out Sheet shall be recorded as DNF."  <i>Explanation: To avoid any ambiguity as to what sanction should be applied if a rider is in breach of Regulation 17(b).</i></p>		
23.	<p>By South Wales DC  <b>Limitation of Entries</b>  Regulation 26 (page 345)  Add the words 'in Type A events' to the end of the first sentence. Thus it reads:  "Unless otherwise declared in writing to the District Council, when applying for the event*, selection of riders shall be on the fastest performance recorded during the current and past three years at the event distance in Type A events."  <i>Explanation: To limit selection to performances in Type A events.</i></p>		
24.	<p>By the Board of Directors  <b>Limitation of Entries</b>  Regulation 26, second paragraph (page 345)  Delete the second paragraph beginning "All excess entries..." and replace with:  "In cases of excess entries, a rider must be informed promptly as soon as it is apparent their entry is not to be accepted."  <i>Explanation: The majority of entries to events are now internet entry and the requirement to return entries by first class post is obsolete.</i></p>		
25.	<p>By South Wales DC  <b>Limitation of Entries</b>  Regulation 26 (page 345)  At the end of the first paragraph, add a new sentence as follows:  "If there is no performance at the relevant distance and the event is oversubscribed, selection shall be at the organiser's absolute discretion after accepting all riders with a qualifying performance first."  <i>Explanation: To formalise custom and practice where the fastest qualifying riders are included and then the organiser accepts other riders on a best endeavours basis.</i></p>

## Regulation 26(d)

In the second sentence, delete the words "selection of women shall be on fastest performance as above" and replace with "selection for the remaining places shall be on fastest performance for both sexes, based on a normalisation factor of 88% where women's times are multiplied by 0.88 in order to rank those times with men's.

*Explanation: The current rules dictate that race organisers must reserve 20% of the race entries to women. While this is sufficient for races in which fewer than 20% of entries are from women, it becomes very unfair to women if women make up more than 20% of entries. The current system takes male and female LTS times on an absolute basis with no consideration to the slower times produced by women compared to men of the same average ability. Therefore, after the 20% entry is reached, women are disproportionately cut from the entry once absolute times for LTS are used to determine a cut-off time.*

*In-depth calculations have been carried out to work out a 'normalisation factor' to convert women's times into times that can be directly compared to men's. That figure is 88%, or 0.88. For example, a woman who has a personal best time on a 25 mile course of 1:02:00 will have an adjusted PB time of 54.34. Instead of using a female rider's actual time, a race organiser will use this faster, normalised time when determining entry cut-off times. A female rider's adjusted time would be automatically calculated by the CTT website and provided to race organisers so that this new approach would not require any additional work on the race organiser's part.*

*At many of the events that London Women's Racing included and promoted in their series in 2017, we saw between 20 to 50 women enter (a huge difference from many races we've attended in the past in which there were only a very small handful of women racing). We believe that races with larger fields of women are a benefit to the sport, and by extending the 20% rule to equalise performances between men and women, more women will be encouraged to compete and progress.*

nb. There is an error in the 2017 handbook and Regulations 26(b) and (d) currently read (and as is shown on the CTT website) as follows:

(b) In events counting towards the R.T.T.C. Women's Best All Rounder Competition, 20% of the places and 20% of the reserve places must be reserved for women. Where there are more women entrants than allotted spaces, selection shall be on fastest performance as above.

(d) In all mixed events that do not have special conditions relating to entry levels, 20% of all places and 20% of the reserve places must be reserved for women. Where there are more women entrants than allotted spaces, selection shall be on fastest performance as above. Where there are fewer women than this, men may fill the places.

34.	<p>By West DC</p> <p><b>Duties of Promoting Secretaries</b></p> <p>Regulation 27(h) (pages 347)</p> <p>Delete: The starting order shall be arranged with the faster competitors spaced at not less than five minute intervals. Other competitors shall be arranged in such a way that company riding is as far as possible avoided.</p> <p>Insert: Save as otherwise provided, the Event Secretary shall have discretion to arrange the starting order as they wish bearing in mind the characteristics of their event and the need to avoid company riding as far as possible.</p> <p><b>Explanation:</b> <i>As currently drafted, the regulation requires event secretaries to organise the start list with the faster competitors interspersed throughout the field. This has the following problems:</i></p> <ul style="list-style-type: none"> <li>• <i>Setting of riders of similar abilities at different ends of the field inhibits fair competition since weather and traffic conditions can vary substantially throughout an event meaning that riders of similar abilities do not compete on a level playing field.</i></li> <li>• <i>It causes unnecessary holdups when traffic backs up behind a slower rider on a single carriageway course preventing other riders from overtaking.</i></li> </ul> <p><i>The startsheets for most of the RTTC national championships and the RTTC Classic Series are arranged slowest to fastest. This practice is sensible, it works but it is in breach of the current regulation. These problems could be mitigated if event secretaries had the power to tailor their startsheets to their events - for example setting the field slowest to fastest in short time trials where there is little risk of riders making the catch.</i></p> <p><i>Of course, if event secretaries wish to continue seeding their events as previously then the amended regulation allows for this. The amendment simply gives event secretaries flexibility to use their initiative when setting their fields.</i></p>
